1 QFA INC. RULES RELATING TO REGISTRATION OF CATS – PREFIXES.

- (a) Every breeder is required to register a cattery prefix with a recognised governing body.
- (b) Four (4) names to be submitted in order of preference on the application form and returned to the Registrar with the prescribed fee. If applying for an experimental prefix, then the experimental program must be approved before the prefix is applied for. Select all names carefully as once prefixes have been checked and approved they will not be changed. Holders of prefixes who change their names by marriage or Deed Poll must notify the Registrar, however the prefix itself cannot be changed.
- (c) The QFA Inc. will not register a cattery name in the form of an affix e.g., "QUEEN OF MAYBURY". The cattery name must come first, e.g., "MAYBURY QUEEN".
AS A GUIDE TO BREEDERS, LISTED ARE TYPES OF NAMES WHICH ARE UNACCEPTABLE: -
Christian names e.g. TOM/ZOE – Town names e.g. ROMA/ESK – Jewel names, e.g. RUBY/TOPAZ
Flower names e.g. ROSE/VIOLET – Colour names e.g. LILAC/SILVER. Words like STAR/BREEZE
*****STREET NAMES ARE ACCEPTABLE IF SUITABLE*****
- (d) All words used as prefixes must be registered. No breeder may apply a prefix to a cat's name without first having the prefix registered.
- (e) NO BREEDER MAY KNOWINGLY USE THE PREFIX OF ANOTHER BREEDER EITHER AS A PREFIX OR IN THE COMMON NAME OF A CAT. A registered prefix is not transferable.
- (f) Prefixes must be renewed annually and a Breeder's registration fee must be paid by the 31st July in each year. Failure to fulfill any of the provisions of the QFA Inc. breeders' Code of Ethics, sign the current agreement and pay the prescribed fees may preclude the Breeder from using the services of the QFA Inc. Payment of the Breeder's registration fee does not constitute membership of the QFA Inc.
- (g) Every Breeder should be aware that if a written complaint is received about him/her, then the QFA Inc. may withdraw its services pending a resolution of the complaint.
- (h) Use of a prefix shall lapse on the death of the holder and shall not be used again for twenty years.
- (i) Should a breeder decide to cease breeding, the prefix may be lapsed on written application to the Registrar. Such prefix is not to be used again by another breeder for twenty years.
- (j) Persons wishing to register an interstate or overseas prefix with the QFA Inc. shall apply in accordance with Rule 1(a).
- (k) Prefixes shall be granted only to the owner/s of a registered cat.
- (l) All queens must be registered with QFA before a litter can be registered from them.
